**Subject: Waste collection containers**

In accordance with the Waste Management Act (Official Gazette, No. 84/2021), local governments are obligated to ensure the performance of the public service of municipal waste collection as a service of general interest.

For this reason, the City Assembly of Zagreb adopted the Decision on the method of providing the public service of municipal waste collection in the City of Zagreb (Official Gazette of the City of Zagreb, 7/22).

As part of the comprehensive implementation of a sustainable waste management system in the City of Zagreb, Zagrebački Holding Ltd., subsidiary Čistoća, is preparing a public procurement procedure for Waste collection containers:

- Group 1. – 120 l plastic bins,
- Group 2. – 240 l plastic bins,
- Group 3. – 360 l plastic bins, and
- Group 4. – 1,100 l plastic containers.

Before launching the procurement procedure, subsidiary Čistoća is conducting an additional market analysis with the aim of learning about the current offer of municipal equipment - waste collection plastic bins/containers and to gather information that will contribute to the preparation and drafting of tender documentation.

For the purpose of market research, subsidiary Čistoća invites interested economic entities who offer 120, 240, 360, and 1,100 l containers in their product range to submit non-binding information offers and express interest in presenting the mentioned/listed products.
